Hi Cameron and Viktor - Apparently, Lotus wrongly shipped COMMDLG with their AMI Pro 2.00 product. They picked up the beta 1 COMMDLG which was NOT included in the list of files available for redistribution. We need to contact them, have them update to the beta 2 release of COMMDLG and notify their customer base that they need to upgrade COMMDLG or they may affect other software components that use COMMDLG.

We did not give them permission nor did they ask anyone here to include COMMDLG with AMI Pro 2.00. They also ship OLECLI and OLESVR from beta 1 which is fine.

This issue was brought to my attention because it is affecting QC/Windows. (JeffBe has more details if you want them)

Please look into this asap. If you have any questions, please let me know.
