AMENDMENT NUMBER 11
Amendment Date: May 1, 1995
to LICENSE AGREEMENT FOR MICROSOFT PRODUCTS #1107-3053
between MICROSOFT CORPORATION, a Washington, USA Corporation
and COMPAQ COMPUTER CORPORATION, a Delaware, USA Corporation

Effective as of the Amendment Date indicated above, the below signed parties agree to amend the above referenced license agreement (hereinafter the "Agreement") by this instrument (hereinafter the "Amendment") as follows:

- 1. In accordance with Exhibit S(2) of the Agreement, MS will license selected source code files from WINDOWS NT 3.5 and WINDOWS NT 3.51 listed below in 1(b) ("Product") to COMPAQ as follows:
(a) COMPAQ may modify and distribute Product in object code form as part of a COMPAQ developed installation and configuration application diskette called "Windows NT 3.5 Graphics Support Disk for COMPAQ Systems" or "Windows NT 3.51 Graphics Support Disk for COMPAQ Systems" ("COMPAQ Applications").
(b) For purposes of this Amendment, "Product" shall include the following files and such other files as are reasonably required by COMPAQ to develop COMPAQ Applications:


