1. Key Accomplishment

NEC

An agreement for CD-ROM Extensions was closed.

We have pushed NEC to bundle Windows. At last, NEC announced machines bundle Windows. The name of the machines are PC-98GS and PC-9800CS5/W. NEC also announced to prepare a machine pre-install MS-DOS. The name of the machines are PC-9800NC and PC-9800CS.

4. Significant OEM opportunities in progress

NEC asked us to reduce 15% to 40% of royalties of DOS and Windows. Their demand is to set royalties at the lower rank which means to change the royalty for 386SX for current 286 royalty. This is really a serious matter. I don't astimate how big it influence our revenue yet. I will estimate it and report to you as soon as possible.

An Amendment to J015-8327 for MS-DOS 2.11

This amendment is still on the way of NEC's signature.

But additional M/C came into issue. NEC intended to pay \$30K due on signing. However, it was ascertained that they should pay only \$500 due on signing though additional M/C is set at \$30K because this agreement is so old that "Initial Term" is not defined in the agreement. So we have to write side letter to make confirm of this.

An Amendment to J015-9285 for ROM-DOS 2.11.

I offered the conditions that Royalty is \$3.5 and additional M/C \$700K to NEC HE. They basically agreed with the conditions. We don't have any issues.

Next Step is that NEC will provide machine names and so on to be described in Exhibit D. Then I will make a draft. I expect this deal will be completely closed by the end of this year.

Kanji CS status

In a contractual point of view, we are still waiting for NECs comments to the localization agreement though they said that they gave us their comments by 9/12. Anyway, we will have a meeting on 10/9. Then I will get their comments. It embarrasses us that NEC lawyers make slow progress.

HIGHLY CONFIDENTIAL In a technical point of view, We had the technical training from 9/9 to 9/11 in Scattle. Unfortunately I couldn't attend the training. So I'm not sure the detail, but so many questions that NEC asked were clarified.

But judging from the attendees' impression in MS side, It seems very tough to develop Kanji CS. Because NEC actually Chubu NEC Software Corp. is developing, is not accustomed to develop a software with the source code and they are not good English speakers.

I will hold a follow- up meeting on 10/9.

Kanji SQL status

In a contractual point of view, I received their comments and had a meeting with Marty, who is Iswyer and work for PTSG, and Nancy. Marty will contact Sybase and get Sybase's comments. But we felt it's impossible that Sybase accept NECs comments.

The point of their comments is ,I feel, that NEC don't want that Sybase is expressly entitled to monetary relief.

I will have a meeting on 10/8.

Pen-Windows

As you already know, we had meetings with NEC and NEC HE.

The issues that I'm concerned are;

- Schedule delay of Pen-Windows US. Pen-Windows schedule depends on Windows 3.1. Windows 3.1 is scheduled to be released January though it's scheduled at the end of this year at first. And Windows 3.1 schedule tends to be delayed. Mr. Tosaka, who is General Mauager in 2nd OA, is very concerned export PC because he recently took over export PC. He also takes charge of domestic PC still.). At this meeting, we explained that Pen-Windows ODK would be shipped at the end of this year. If the schedule will be delayed, It becomes big problem.
- Schedule of Kanji Pen-Windows. NEC still want to launch kanji pen-windows in May '92. Our current schedule doesn't match their request. So Pen group and KK R&D discussed this issue and at the result of the meeting, we may be able to ship kanji pen-windows in spring '92 but this is not fixed.

5. Significant OEM events

NEC announced the following 5 types of PCs.

At the same time, NEC announced MS-DOS 5 and Multimedia Extensions.

Fon

We had a meeting regarding Font issue. Actually NEC Office System Corp. is making font business. NECs strategy about font is to disclose specification of font I/F and bundle TrueType font without hint into Windows 3.1 when Windows 3.1 is launched.

MultiMedia

We had a meeting to discuss multimedia strategy in Japan.

In a sense, Fujitsu go ahead of multimedia. NEC regard themselves as top runner in PC world so they are destined to abip MS product fastest than other OEMs. That's why NEC was flustered.

Our issue is that the specification of MPC US is irreconcilable. It means that we cannot ignore NEC nor Fujitsu that is making business in cooperation with MS according to our strategy.

The result of the meeting is that it's better not to define MPC-J. This is a sort of strategy. Actually NEC or Fujitsu can recruit more ISVs than MS recruit with defining MPC-J.

And NEC's strategy regarding multimedia is not to manufacture new PC for multimedia but to target existing 4.8 million users. So NEC prepared a kind of upgrade kit. However They also prepare dedicated multimedia PC for professional. That's PC-98GS. They expect their competitor is not Fujitsu nor IBM, but Apple.

NEC:

- Offer new royalties.
- make a draft to consolidate an agreement to NEC HE into the agreements to NEC 2OA.
- Proceed with Kanji CS localization agreement
- Proceed with an NDA for Kanji SQL
