### Policy and Pricing

This should not be "sold" to OEMs. Use for reactive purposes only. Upgrade rights from this point on will be available only to MDA OEMS that demand it.. In all cases there will be a \$6.00 localization adder for all Euro languages (other than UK English). There will be no formal WW PGL - Pricing will be account /volume/region specific and must be approved by JK prior to even offering it to any OEM. ALL OEM purchases must come through a MS order clearing desk here in the U.S. MS will then authorize a fixed qty of upgrade product that the OEM may purchase from the Designated AR. There is a form attached to the Agreement that the OEM must FAX to MS when they place orders and wire transfers.

# Agreements -

We will keep the existing Upgrade Amendment for OEMS that can be talked into US English only upgrades. We will create a "new" Amendment that will include the European distribution rights and the following new terms and conditions.

- 1. Direct fulfillment must be provided by an approved 3rd Party. Not by COMPANY.
- 2. Distribution will be limited to the US and Europe.

The existing terms in the US/UK Exhibit will apply to this exhibit at well:

- 1. Company sources the upgrade through a single AR of their choosing (maybe limited in europe).
- 2. OEM must ensure that end user system was purchased between July 1 and Oct 1.
- 3. Company must Pre-Pay for this product.
- 4. Product must be physically marked as an "Upgrade"
- 5. Direct fulfillment only (now via 3rd parth)
- 6. OEM must support the upgrade as well as the
- 7. OEM License right to distribute expires November 30, 1995

8. Availability from the AR ends October 31, 1995.
