Here's current situation:

Dell is currently being told two things by Microsoft. 1) Richard Barrie is attempting to get them to sign the new wording to the contract which prohibits the sale of SBE into Federal. Dell is reluctant to do this, however I am confident they will agree to the terms. 2) Pete Hayes has told Dell he will give them a 3 month grace period from implementing the new terms, as we are currently in the heaviest purchasing season for Federal which extends through September. This is a reasonable compromise due to the timing of the changes. However, Richard Barrie is not supporting Pete's position.

Kristin is working with Pete and Richard to come to agreement. My assessment is that this policy will go into effect Oct 1 across all OEMs selling into Federal.

Look forward to coming to resolution on this.

My fellow SBE licensees,

I have added the following additional provision to Dell's SBE agreement to stop OEM SBE getting into the federal space. As you can see, I need your assistance because of the "unless other OEMs..." language. (The LAR sentence may not apply to you) Can you add this to your agreements at the earliest possible moment to stop pollution of the Federal market and stop our Federal folks from complaining about this

(I) Notwithstanding anything to the contrary in this Agreement. DELL is not licensed to distribute Office 97 SBE (and no royalties shall be due) to the federal government under this Agreement unless MS licenses other OEMs to do so. DELL may continue to distribute Office Professional to the federal government under Dell's current LAR Agreement.
