Since the attached PGL we have also deleted additional items in line with the termination of third party licenses. These are:

- Nickelodeon 3D Movie Maker; termination of third party license.
- Rabbit Ears: P.J.'s Reading Adventures; termination of third party license.
- Rabbit Ears: Leopard v1.x; termination of third party license.
- OutWars; only one OEM deal to date w/w which is set to end January. SKU has java issue but will not be re-released.
- Oceans and Dangerous Creatures were also removed due to termination of third party license.

On all of the above ... we will allow existing licenses to ship through to expiration but no new licenses should be created.

Additionally we have agreed a new PGL pre publication review process.

My comments:

1) Fighter Ace & Zone internet property with playtime you state [below] requires 200K and up to license but the PGL has entries in the 100K and up columns. We still need to review and approve the licensing exhibit for this when it's ready. During review let's think now about what other items are going to get dragged down into the space that subsidizes low margin PCs and whether it makes sense to do it.

[Michael Dwan] Yes you are correct pls delete the 100k entry and we will restrict this to over 200k volumes. I had worked with SallyN on the exhibit before my vacation so let me know if more work needed to finalize. The other online property is Encarta online but I did not add this to the PGL at this time as I don't want to popularize it beyond PB/NEC until we learn from our experience there.

2) Money 99 reduced footprint I don't see a footnote requirement for recovery CD option. Since the CD is absent there should be a requirement for this to be present on the recovery CD.

[Michael Dwan] Good point we should add this requirement do you want me to cover with SallyN in the APs and a foot note in the PGL also ?

3) All items with DVD media should require a backup media be shipped. I don't think we have resolved completely the issue of DVD as a recovery media type and the implications of having titles live on a DVD recovery media when they are [possibly] engineered to be present in the drive in order to execute.

[Michael Dwan] For the DVDs offered by IMG on the PGL these will only be available to OEM with the DVD ... so recovery media is present.

4) The issue you state below of equating Works royalty with the Encarta royalty seems to suggest we need to raise the Works royalty. Kurt needs to comment on the history you mention.

[Michael Dwan] We can approach this is two ways either increase the price of Encarta or decrease Works either way we believe they should align at higher volumes and this is what we discussed with Kurt previously.

5) Will you write a summary of the changes that merit highlighting so they can accompany the announcement of the latest PGL.

[Michael Dwan] Here is the mail I sent earlier for the announcement ... is this OK ?

As an audit trail (we learned from your advice last year!) PGL entries are color coded as follows:

Red = Revised

Blue = New

Black = Unchanged

Strikethrough = Deleted

We also left a codes in the left column to assist your sort of the color codes (Unchanged, Revised, Deleted, New).

Formatting: we have inserted an additional column for OEM release date and we have added additional information on NT compatibility to the platform column as we were receiving many queries from SEs and AMs. We also request that our new easy to read header formats are retained for publication.

- Encarta Encyclopedia: substantially reduced royalties at 25k and 10k volumes, this is good for international in particular.

Issues for discussion:

- **Encarta:** in preparing this PGL we reviewed the DAD PGL and found that Works is priced above Encarta at the 50k -500k volumes. As you recall we previously agreed to align Encarta and Works pricing at these volumes. However we heard from Edmcc that you'd approved his new increased price PGL for Works. We suggest aligning the Works pricing with our Encarta price at these levels.
