I talked briefly with Steve at the Java design preview we're currently hosting in Redmond. Steve mentioned that he's currently trying to influence future VM direction at Apple. There is a group at Apple who are working on a VM, but given the work we're doing in the Win32 and cross platform space, Steve feels that this Apple work isn't useful. He enquired whether the sources to the Win32 VM are/would be available for them to use/port. I explained that our sources were available from Sun and that he should contact Sun for them. Note that these sources don't necessarily include all the pieces that he would be interested in.
