

# AMENDMENT

Amendment 1  
to the License Agreement  
between  
ZEOS INTERNATIONAL and MICROSOFT CORPORATION  
Dated May 22, 1990, Contract No. 4934-0131

This Amendment to the License Agreement ("Agreement") between ZEOS INTERNATIONAL ("COMPANY") and MICROSOFT CORPORATION ("MS") is made and entered into this 1st day of July 1991.

The parties hereby agree to modify the Agreement as follows:

1. Upon signing this Amendment, COMPANY shall be relieved of existing minimum commitments under this Agreement as of the date of this Agreement.
2. COMPANY agrees to a minimum purchase commitment of Four Hundred Six Thousand Dollars (US\$406,000.00) worth of Product Hardware during the period of July 1, 1991 and January 31, 1992 at the unit price specified in Exhibit C.
3. Replace Exhibit C with attached Exhibit C.
4. In the event of inconsistencies between the Agreement and this Amendment, the terms of this Amendment shall be controlling.

IN WITNESS WHEREOF, the parties have executed this Amendment to the Agreement as of the date set forth above. All signed copies of this Amendment to the Agreement shall be deemed originals. This Amendment does not constitute an offer by MS. This Amendment shall be effective upon execution on behalf of COMPANY and MS by their duly authorized representatives.
